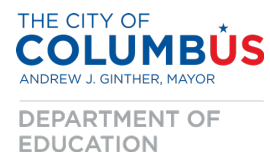

Example of your investment at Work:

- \$250** Provides transportation for up to 20 youth
- \$500** Helps 15 youth attend one night of programming
- \$1000** Funds an entire field trip for youth to take around Columbus
